<u>Funds</u>

All figures above are based in U.S. Dollars and represent the <u>minimum amount</u> of funds required to issue your immigration documents (I-20 for F-1 visa applicants or DS-2019 for J-1 visa applicants).

If you receive an academic scholarship from Xavier University, you may deduct the scholarship amount from the total cost of attendance shown in the table above.

Accommodation and medical insurance & other fees are estimated expenses.

Living with Relative or Friend Off-Campus

If you plan to live with a relative or friend off-campus, we require a <u>notarized statement</u> from your relative or friend stating that you will be living "free of charge" at their house.

If a letter is provided, you will only need to submit proof of funds for accommodation in the following amounts:

- One Year: \$7,500
- One Semester: \$3,500

<u>Dependents</u>

The following <u>additional</u> funds must be shown in order to issue immigration papers for dependents:

- First dependent: \$4,500
- Other dependents: \$3,500 per dependent
