Report of Administration – Chief Warfel XUPD

- Recent partnerships with student organizations (I.e. Crosstown campout, Crumbl cookie check in, Chill and Grill, Candy Canes w/ SGA, Manresa)
- New safety resources:
 - Safety input, training, and advice offered by XUPD
 - Free on-demand training programs
 - Residence Hall Resource Officer Association (RHROA)
 - Campus-wide safety alerts
- Safety on campus advice
 - XU Guardian app
 - Keep phone charged, easily accessible
 - Travel in groups
- Car break-ins and theft updates
 - Break-ins have reduced in number, but still must be cautious
 - Keep cars locked and valuables removed
- Res. Hall vandalism

- Vandalism despite camera installations
- Increased XUPD surveillance in these areas
- Witnesses are the best way to combat - hold each other accountable
- Ethics point – online and anonymous reporting hotline
- Dispensary commentary
 - Xavier is a smoke free and drug free environment, regardless of whether you are 21+
 - In order to get federal funding, we must remain drug free and follow the stipulations
 - Will be very restrictive, should not use fraudulent identifications
- Third annual Citizens Academy- learn about the law enforcement profession and campus initiatives
 - Tours of local departments, coroner's offices and crime labs
 - Do NOT have to be criminal justice to be interested!

Q&A

- Q: Any procedures in plan to enforce cannabis use given the new development?
- A: Bottom line is it is a violation of student code of conduct and there will be repercussions, despite being of age. New policy enforcements are being investigated.

- Q: If I have a Hyundai or Kia, can I park somewhere specific or safer to prevent a break-in?
- A: Long term, yes. If you are traveling away from campus for a longer time, tell us, and we will help you. For daily parking, not as feasible.

- Q: What are the details of the new policy you are working on in residence halls when it comes to the new dispensary?
- A: If there is a scent of it there, RA's will track it down and get law enforcement involved immediately. We will take steps to make sure that folks pushing it on campus know it is not acceptable.

- Q: For a marijuana violation, will that be handled only by law enforcement?
- A: It is a combination of RA and XUPD as necessary.

- Q: Does every floor of Res Halls have a camera?
- A: Depends on the residence hall. Almost all have entry and exit cameras with cameras at main control points. Previously, many did not want any sort of camera in residence halls. But now, there is more of a safety expectation and surveillance factor with cameras in today's culture. The problem is that the installation is not cheap. So, we

must explore what offers us more effective ways of reaching greater areas with less cameras. Currently working with project management, student affairs, residential affairs, to fix this coverage.

- Q: Safety concerns with possibly lengthening swipe in hours for Alter Hall?
- A: We try to be flexible and accommodate for certain students' needs (art students working on projects, etc.). We must make sure we know what specific need is being met by granting late-night access. Further, adds another layer of patrol regarding walk throughs for these spaces and shifts attention away from other buildings who are more vulnerable to break ins, theft, and damages.

- Q: Are any officers combating the H lot triple parking issue?
- A: We will let our officers know to keep an eye on that and cite as needed. There is space for those vehicles, but triple parking is never acceptable.

- Q: Current and future prevention projects for car break-ins?
- A: Long-term cars are the ones being targeted, but people are getting bolder when it comes to these vehicles. One thing we are looking at regarding parking facilities is a system called iPark. Used to help officers regulate parking issues. More details to come when/if that gets implemented.
